

**Exclusive Shell Lubricants EOFY Special Offers Promotion
Terms and Conditions**

1. Information on the offer and how to claim the offer form part of these Terms and Conditions. Participation in this Promotion is deemed acceptance of these Terms and Conditions.

2. The Promoter is Viva Energy Australia of Level 16, 720 Bourke Street, Docklands VIC 3006 ABN 46 004 610 459 and its agents in the promotion, including their officers, employees and agents (collectively called the "Promoter"). No correspondence received concerning this promotion will be entered into.

3. The promotion commences at 9am AEST on Wednesday 1 May 2019 and closes at 5pm AEST on Wednesday 31 July 2019 ("Promotional Period").

4. This Promotion is only open to Australian residents 18 years or over, who purchase the minimum quantity (as set out in Clause 6 below) of participating Shell Lubricants products in a single transaction (Products detailed in Clause 6 below known as "Participating Products") from any participating Inenco Group branch or website ("Participating Branch or Website") during the Promotional Period and who complete a redemption request in accordance with Clause 14 below.

5. Employees (and their immediate families) of the Promoter, participating sales agents and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

8. For the purposes of these Terms and Conditions, the following definitions apply: 'Purchase' means order placed and payment made in full for the Participating Product during the Promotional Period from an Australian participating Inenco Group Branch or Website.

16. The Promoter reserves the right, at any time, to verify the validity of claims and claimants (including a claimant's identity, age and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

If a claimant has not received their purchased item from the branch or website at time of payment, claimants are still eligible for the Bonus Gift if they have paid in full within the Promotional Period. Purchases or claims showing incomplete payment for the participating Products will not be accepted. The claimant MUST however lodge a claim before the end of the Redemption Period.

18. Incomplete, indecipherable or illegible claims will be deemed invalid.

19. The Promoter's decision is final and no correspondence will be entered into.

20. The claimant must retain their original purchase receipt as proof of purchase. Failure to produce either the original or a copy of the purchase receipt when requested may, in the absolute discretion of the Promoter, result in invalidation of the claimant's claim and forfeiture of any right to the Bonus Gift.

22. The Promoter accepts no responsibility or liability in relation to any delay in satisfying any claim for the Bonus Gift.
